If you answered yes to those questions, then you should attend the Youth Leadership Congress at UW–River Falls from July 26-28, 2017.

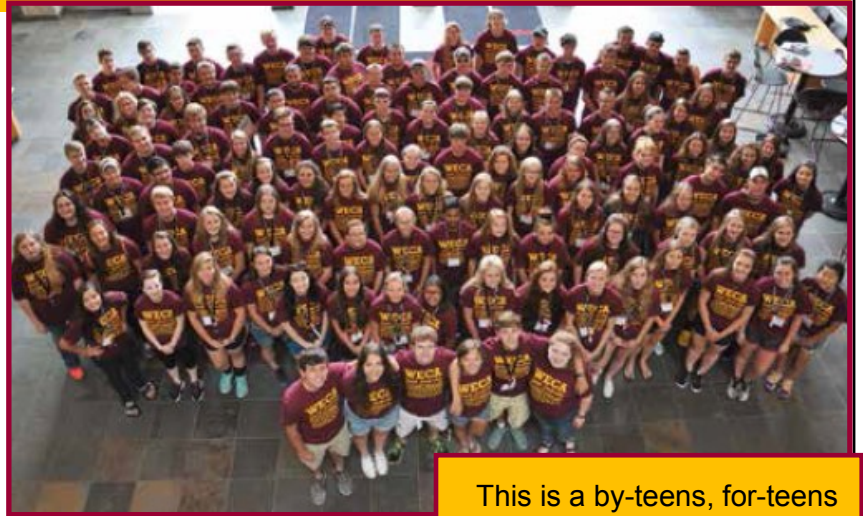

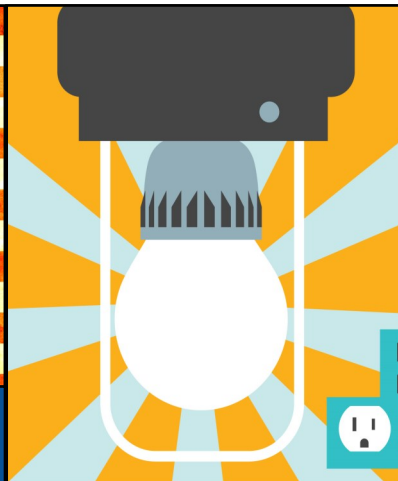
